A. TERMS AND CONDITIONS OF BID

- 1. A sealed envelope should be used for submitting price bid, superscribing on the envelope "BID NOTICE FOR DISPOSAL OF OBSOLETE THREE-WHEELER FOR SCRAP PURPOSE ONLY".
- 2. The bid may be sent by post sufficiently early so as to reach the NIFT within time, or may be delivered to the undersigned. If bid is sent through Messenger, an authority letter from the tenderer with proof of identity may also be given to the Messenger so that he could show the same along with his own identity proof to the Protocol Officer in Administration Department for issuance of Entry Pass.
- 3. The bidder is expected to examine all the instructions, Proforma's terms & conditions and specifications in the tender document. Failing to furnish all

information required by the document in any respect will be at the bidder's risk and may result in the rejection of the bid.

- 4. The sealed envelope must be received not later than the date & time specified for submitting the same. In case, the date of submitting the bid will be declared as holiday by the Govt. of India then next working day will be treated as due date of tender.
- 5. The bid will be confirmed in favour of the person offering the highest bid in respect of that vehicle.
- 6. The NIFT will deal with bidder directly and no middlemen/agents/commission agents etc. should be asked by the bidder to represent their cause and they will not be entertained by the NIFT. At the bidding, any bidder/s trying to form cartel with other bidder to otherwise influence the bidding process may be evicted and will be declared disqualified.
- 7. The NIFT reserves the right to make any change, at any time, in terms and conditions of the Notice Inviting Bids and accept or reject any or all tenders wholly or partly without assigning any reason thereof. The decision of the Committee of Officers conducting the disposal of vehicle shall be final.
- 8. Over-writing/over-typing or erasing of the figurers which render it doubtful or ambiguous are not allowed and shall render the bid invalid.
- 9. Quotations including the documents submitted therein must be duly signed and stamped failing which the offer shall be liable for rejection.
- 10. Each bidder has to certify that all the terms and conditions are acceptable to him/her.
- 11. Each bidder will be permitted to offer his highest bid over and above the reserve price. Sale will be fixed in favour of the bidder offering the highest bid of the vehicle.
- 12. Reserved price fixed at Rs. 7500/- of the above said vehicle.
- 13. 50% of the reserved price of the vehicle is to be deposited by the highest bidder immediately on the same day which will be provisionally accepted, by way of Demand draftor Pay Order.
- 14. The vehicle will be disposed of on "as is where is basis".
- 15. Each page of tender document should be signed by the bidder.
- 16. The quotations below the reserved price will not be entertained and liable to be rejected.
- 17. The written Bid(s) shall not be less than the reserve price of the vehicle, as mentioned in **Annexure- 'A'** but may be more than that.

- 18. On final acceptance of the bid, the remaining balance amount of the accepted bid amount is to be deposited by the highest bidder within one week of communication of the acceptance to the bidder, failing which amount already deposited shall stand forfeited and vehicle will be put for sale as scrap. After depositing the remaining balance amount, the vehicle will be handed over to the highest bidder.
- 19. The successful bidder will have to abide by the terms and conditions as may be fixed from time to time by the Director (Head Office), NIFT.
- 20. The vehicle is being sold as a scrap and hence the successful bidder shall dismantle and remove the same from the campus. The successful bidder shall not use it in original form or convert it in any form of other vehicle as passenger / carrier and use it for commercial purpose and if used it will at their risk and cost.
- 21. The vehicle identification plate (the one that has the engine and chassis number engraved on it) shall be removed by the successful bidder and handed over to NIFT for keeping it under its custody before handing over the vehicle.
- 22. The successful bidder shall engage his own arrangement for the purpose of taking delivery of vehicle in question.
- 23. The successful bidder shall take delivery of the vehicle, at his own cost and responsibility and in any case within the time prescribed for this purpose. NIFT shall not in any manner be concerned with or responsible for the vehicle, and will have no liability whatsoever after the delivery of said vehicle to the successful bidder. It shall be presumed that the bidder has fully inspected the vehicle before the sale. The NIFT shall not be responsible and shall not entertain any complaint in respect of any defect in the vehicle.
- 24. Interested parties may send their sealed bid containing the "Bid Document" superscribing on the envelope "BID FOR DISPOSAL OF OBSOLETE THREE-WHEELER FOR SCRAP PURPOSE ONLY", addressed by name to the Asst. Director (Administration), NIFT, so as to reach on or before 28.03.2022 (Monday) upto 2:00 p.m. which may be opened on the same day i.e. 28.03.2022 (Monday) at 3:00 p.m. in the Office of Senior Asst. Director (Admin.) NIFT, by a Committee of Officers constituted for the purpose before the bidders or their authorized representatives who may wish to remain present. In the first instance, envelopes containing tender documents will be opened.
