The expected roles and responsibilities of the CEO are as below:

Managing NFDI:

- Setting up NFDI, making it fully operational.
- Building organisational structure, and recruiting right team.
- Infrastructure planning and execution.
- Networking with various stakeholders and potential entrepreneurs;
- Instituting systems for identification and incubation of potential entrepreneurs and start-ups to be supported by the NFDI
- Assessment of Business proposals for incubation;
- Development and implementation of Business strategies;
- Development and putting in place of policies and processes;
- Fund raising and deployment planning;
- Consistent revenue stream generation;
- Development of Long term Plans and Strategy.

Creating Ecosystem:
