1. The Purchaser reserves the right to increase

or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. **Bidder Financial Standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

The fault must be rectified within 3 days from the Complaint and major hardware replacement must be resolve maximum in 7 days from the Complaint failing which the penalty @0.5% per week will deducted from respective bill (Quarterly basis) with maximum ceiling of total 10% of the total quarterly bill value.
- IV. The contractor should provide spare parts, up-gradation of software and hardware free of cost.
- V. The contractor has to replace all spares (which must be genuine) free of cost excluding consumables; (i.e. consumables are Drum, Drum Kit, developer, Fuser Kit, Exposure lamp & Toner).
- VI. The contractor should provide the routine service of above machine on quarterly basis and submit the service report to Computer engineer.

of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
