1. The GeM Bid invited for “Comprehensive AMC OF RO AND WATER COOLER in the various parts of the NIFT Raebareli Campus on “As is where is basis”.
2. The Contract covers attending to any number of breakdown calls and four comprehensive maintenance services in a year during the tenure of the contract apart from preventive maintenance.
3. **Scope of Work for RO :** - Any part required for proper functioning of RO's including membrane, filter and other parts (Electrical & Mechanical) which require repair /replacement due to normal wear and tear during the contract shall be replaced free of cost. Membrane & filter should be change mandatory in every year during the contract period and if required the same may be changed as per requirement to provide the water as per standard norms.
- Scope of Work for Water Cooler :** - Any part required for proper functioning of Water Cooler's including supply of all material spares, replacement /repairs of compressor from OEM's or from market, gas charging , air filter, electrical parts servicing, overhauling, greasing, starting relay, overload protector, wiring repairs, motor rewinding with bush and shaft, tapes including handling charges, blower motor/outdoor fan motor etc complete in all respect for ensuring the desired levels of cooling. This comprehensive AMC is also including repairing of body and changing of taps from time to time. No extra payment will be made for non-functional of water cooler.
4. After completion of the contract, contractor has to hand over the systems in perfect running conditions (Complete in all respect as per inventory) to the department.
5. Water and power shall be made available free of cost for bonafide users.
6. Initially maintenance contract shall remain valid for one year and it may be renewed /extended every year for further two years thus making total three years on the same terms and conditions subject to satisfactory performance during the contract period. Nevertheless, the first party may terminate the contract of the second party without any notice in case the contractor commits breach. The decision of Director NIFT will be final and shall be accepted without demur by the second party. No escalation will be provided during the entire period of contract.
7. The payment will be made on quarterly basis as per the quoted amount after deducting TDS as per the existing rates including the cost of men and material for performance of the duties.
8. During the contract period, if the performance is not satisfactory performance guarantee can be forfeited.
9. Any damage resulting to the system on account of negligence or mall operation shall be made good by the contractor. Nothing extra will be paid for such work.
10. The contractor shall arrange to render efficient service as outlined in this specification. However, in case he fails to maintain the service to the satisfaction of the Engineer in charge and if NIFT has to incur any expenditure for maintaining/repairing by alternative arrangement the expenditure thus incurred will be recovered from the contractor.
11. National Institute of Fashion Technology, Raebareli reserves the right to accept or reject any or all the offers either fully or partly without assigning any reasons and is not bound to accept the lowest bid since due weight age shall be given to several factors besides the commercial bid.
12. A tentative list of RO + water Cooler in the given, However, payment to the vender would be made on the basis of the actual no. of equipment attended / serviced during the AMC period. Therefore, it may be noted that the actual number may increase or decrease.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
