1. INTRODUCTION

National Institute of Fashion Technology (NIFT) is a statutory Body Governed by the NIFT Act 2006 & set up by the Ministry of Textile, Govt. of India for the promotion and development of education and research in field of Fashion Technology. NIFT provides Fashion business education across the country through its network of 19 campuses. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Daman, Gandhi Nagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Punchkula, Raebareli, Shillong, Srinagar and Varanasi.

NIFT, Rae Bareli campus was established in the year 2007 and imparting education to 5 (Five) undergraduate and 1 (One) post graduate programmes. NIFT Donations are exempted u/s 80 (G) of Income Tax Act and registered with DSIR, NIFT is entitled for Custom/Central Excise duty Exemption.

2. NOTICE INVITING E-TENDER

The Tenderers are requested to read the instructions in the e-Tender; Terms and conditions carefully before quoting the rates in quotations/Tender schedule and comply with the same there after amendments made if any. No other mode of tender shall be considered and such tender shall not be accepted. Tender document is also available for viewing on the “tenders” link of the NIFT website i.e. <http://nift.ac.in/raebareli>.
- Applications/Bid to this tender will be accepted only through the online mode through <https://eprocure.gov.in/eprocure/app> (CPPP Portal) No other mode of application will be considered & the application will not be accepted.

- c) For applying online, the firm should get itself registered at <https://eprocure.gov.in/eprocure/app> (CPPPPortal).
- d) The bidder needs to mention his Company Name, Address and User-ID to register in CPPP Portal.
- e) The basic requirements for registration and applying for tender online are as under:

- k) The online financial bid will be opened on the date which will be communicated to only those bidders who are found to be technically qualified after evaluation of technical bids.
- l) The interested bidders are advised to read carefully the entire tender document before submitting their tender and the tender documents not received online in prescribed format and/or are found incomplete in any respect will be summarily rejected.

4. SELECTION CRITERIA OF BIDDER

The selection of eligible bidder will be based as per following terms & Conditions:

Technical Bid: The financial bid will be opened only of those bidders who will qualify technical bid.

Financial Bid: Work order will be awarded to the L1 bidder/s who will quote lowest rate for overall work in Indian Rupees (INR).

In case L-1 is more than one, then the overall average turnover of last 03 years i.e. 2021-22, 2022-23 and 2023-24 of the bidders on higher side would be the selection criteria. Selection of successful bidder by NIFT authority in such situation will be one of the final in all respect and will be binding on all the bidders.

5. DOCUMENTS REQUIRED

Tender shall be accompanied by the relevant documents with Technical Bid (**Annexure-I**) duly certified by the firm: -

- (I) The annual financial turnover of the bidding firm during last three years ending 31.03.2024 should be at least **Six Lacs for** each financial year i.e. 2021-22, 2022-23 and 2023-24. Certificate depicting year wise financial turnover of the bidding firms during last three years ending 31.03.2024 (i.e. 2021-22, 2022-23 and 2023-24) duly certified by Chartered Accountant must be attached (submit original scanned copy).
- (II) NIFT invites e- Tenders from reputed Agencies or Contractors having Experience of successfully completed works during last seven years ending on previous day of last day of submission of tender. Three similar works each of value not less than Rs.4,80,000/- (Four lacs eighty thousand only) or Two Similar works each of value not less than Rs.7,20,000/- (Seven lacs twenty thousand only) or One similar work of value not less than Rs.9,60,000/- (Nine Lacs sixty thousand only).
- (III) MSME/NISC/Start-up India firms are exempted from the EMD, Bidder Turnover & Experience Criteria subject to meeting of quality and technical specifications. Firms claiming MSME/NISC/Start-up India relaxation must enclosed copies of their registration MSEs/MSME/NISC/Startup India details validity as on the date of tender opening along with all its amendments for the subject stores. Offer received without these details will not considered for relaxation under MSME/NSIC/Startups.
- (IV) **Profit/loss:** The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during available last five consecutive balance sheet, duly audited and certified by the Chartered Accountant. "Balance Sheets along with Statement depicting Profit/Loss for the each of the three financial years (i.e. 2021-22, 2022-23 and 2023-24) duly certified by Chartered Accountant should be enclosed.
- (V) Solvency Certificate amount equal to (09 lacs) issued by scheduled bank should be enclosed.
- (VI) Copy of Registration Certificate in support of GST and PAN No. (Submit original scanned copy online).
- (VII) The bidder shall be required to deposit the Earnest Money Deposit (EMD) amount of **Rs.36,000/-** (Rupees Thirty-Six thousand Only) in form of Demand Draft / Banker Cheque in favor of NIFT payable at Raebareli. The Demand Draft/Banker Cheque must be reached NIFT Raebareli Campus on or before **02.02.2025 at 03:00 PM**, EMD received after due date will not be entertained.
- (VIII) Those bidders exempted from EMD cost, submit the certificate issued by the concerned department like – "NSIC, MSME etc." (Submit original scanned copy online).
- (IX) Declaration on the Company letter head that the bidder has not been debarred /Blacklisted from participating in tender anywhere in NIFT HO and its Campuses and any Government Department / Public sector undertaking and also declaration to accept all the terms and conditions of tender document as Annexure IV. (Submit original scanned copy online).

General Terms & Conditions:-

1. The rates shall include cost of labours, transport & material for the works complete in all respects.
2. The quoted rates shall include all taxes and GST as applicable and no extra amount shall be payable on this account.
3. Rates shall be valid for six months from the date of opening of financial bid.
4. Water and Electricity will be provided free of cost at one point for Bonafide use.
5. Work shall be completed within 75 days after issue of the work order.
6. The selected contractor/agency shall have to furnish one-year guarantee against any defects/leakage. The sample and brand must be approved by NIFT before commencement of the work.
7. Works are to be carried out as per CPWD specifications.
8. **Security deposit of 5% of total Work Order** will be deposited in the form of Demand Draft in the name of NIFT Raebareli payable at Raebareli within seven days after issue of Work Order. However, EMD amount can be converted to security deposit. The same shall be released after completion fifteen month from the date of handing over of completed work.

9. The payments shall be released against submission of R.A. bills by the contractor at stages of work. The stages to be decided in consultation with the Engineer-in-charge. The final payment shall be released as per actual measurement of works for the work actually executed and accepted by the Engineer-in-Charge. TDS (GST/IT) will be deducted as applicable.
10. If the performance of the contractor is not found satisfactory and not corrected within 15 days of receiving notice, then NIFT shall be at liberty to terminate the contract and get the work executed through other means at the risk and cost of the Contractor. In the event of termination of the contract, NIFT shall be at liberty to get balance work done at the risk and cost of the contractor and due payment of the contractor, if any, shall be released after the completion of whole of the works.
11. If the contractor fails to maintain the required progress of work or fails to complete the work by the stipulated / extended date of completion then the delay damages shall be levied @ 0.5% of the tendered amount per week, subject to a maximum of 10% of the tendered value.
12. Any dispute arises out of this tender is subject to the jurisdiction of Rae Bareli Court only.
13. Payment will be made through NEFT only. The required information for making payment through NEFT duly vetted by banker along with the invoice.
14. No escalation/Variation on the prices on any account will be considered for adjustment/payment.
15. The color and brand/make/specification of the material used may be decided by the Competent authority of NIFT before execution of the works. the L-1 bidder must ensure final approval from the NIFT authority before executing the work with respect to the color, brand/make and other construction material etc. used in the said work.
16. The bidder shall inspect the site of work and thoroughly familiar himself with the nature of work, site conditions and access to the site and location before submission of the tender.
17. Proper care should be taken to provide adequate protection to the existing structures and cables (Telephone, computer etc.), all such installations against any damage/defect to the existing structure arising due to faulty execution of work shall have to be rectified as directed to the satisfaction of Engineer In Charge without any extra charges.
18. Quality control: Regular appraisal of the quality control to the Engineer in charge should be made for effective improvement in the construction techniques to ensure satisfactory quality of work.
19. National Institute of Fashion Technology, Raebareli reserves the right to accept or reject any or all the offers either fully or partly without assigning any reasons and is not bound to accept the lowest bid since due weightage shall be given to several factors (as shall be decided by NIFT) besides the commercial bid.
20. In case L-1 is more than one, then the overall average turnover of last 03 years i.e. 2021-22, 2022-23 and 2023-24 of the bidders on higher side would be the selection criteria. Selection of successful bidder by NIFT authority in such situation will be one of the final in all respect and will be binding on all the bidders.
21. Conditional Bids/Vague offers like **"Duties as applicable"** shall not be considered.
22. NIFT, Raebareli reserves the right to cancel the bid if it considers that there is a cartel formation and that it is in overall interest of NIFT.
23. If the works is not executed after accepting the same, earnest money (EMD) will be forfeited in full and works will be got executed at firm's risk from some other firm. The firm shall also be liable to be black listed as per Government norms.
24. The works should be according to the specifications provided in the tender document. If the works is not executed as per specifications, suitable deductions will be made or the order shall be rejected by NIFT, as the case may be, at the cost of firm's risk.
25. Condition beyond control of either parties like war, hostility, acts of public enemy, civil commotion, sabotage, serious loss or damage by fire, explosions, epidemic, strike, lockout or acts of God come under the legal concept of Force Majeure (FM), Delays in performance of contractual obligations under influence of FM conditions are condonable by the other party without any right of termination or damages, provided notice of the happening of any event is given by the affected party to the other within 7(Seven)days from the date of occurrence works under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. However, if such event continues for a period exceeding 120 days, either party may at its option terminate the contract by giving notice to the other party.

6. CONCILIATION & ARBITRATION

- (i) If any dispute(s) or difference(s) of any kind whatsoever arise between the parties, the parties hereto shall negotiate with a view to its amicable resolution & settlement through a Committee appointed by Director – NIFT Raebareli Centre.
- (ii) In the event no amicable resolution or settlement is reached between the parties within 30 days after receipt of notice by one party, then the disputes or differences as detailed above shall be referred to & settled by the sole Arbitrator to be appointed by Director – NIFT Raebareli Centre.
- (iii) The Arbitration proceedings shall be in accordance with the provision of the Arbitration & Conciliation Act, 1996 & Laws of India as amended or enacted from time to time.
- (iv) The venue of the Arbitration shall be based upon the NIFT Raebareli. The language of the arbitration proceedings shall be in English.
- (v) The Arbitrator will give the speaking & reasoned award.
- (vi) The cost incurred during arbitration, if any, shall be borne by the supplier.
