NIFT Hyderabad invites online tender under two bid systems for “Supply, Laying, Testing and Commissioning of Cable - 3C x 185 SQMM 11KV XLPE (E) HT at NIFT Hyderabad campus” **from eligible Class-1 or equivalent Electrical Contractor/Agencies having valid 11kV and above Electrical license and having at least 03 (three) years of work experience in executing similar kind of works/ jobs** in Central / State Govt. Departments / PSUs / MNCs / Reputed Academic Institutes / Organizations.

1. Please read the terms & conditions carefully before filling up the document. Incomplete tender documents will be rejected.
2. Conditional or offline tender will not be accepted or the condition(s) may not be considered.
3. The bidder shall furnish **EMD of Rs.45,000 (Rupees Forty-Five Thousand only)** in favour of NIFT payable at Hyderabad in the form of demand draft / RTGS from any bank as earnest money deposit (EMD). The bank details of NIFT Hyderabad Campus are mentioned below:

4. Bids without paying the EMD / without valid exemption certificate shall be DISQUALIFIED. **MSE certificate must be in similar category shall be considered.**
5. The Financial Bids of technically qualified bidder only will be opened.
6. Even after qualifying in technical bid, the financial bid may not be accepted if the bid found not in order.
7. The **tenderer must have at least 3years of experience in the relevant field** and execution of similar kind of works in the Govt., PSU, reputed MNCs/organizations.
8. In case if L-1 is more than one, the selection criteria would be at the discretion of NIFT. The decision of NIFT, in this regard and for selection of successful bidder in such situation, will be final in all respect and will be binding on all the tenderers. Preference will be given to the other factors, viz. previous experience, quality of service, number of clients, yearly turnover, etc. to select the agency to award the work and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the tenderers.
9. All Taxes & other charges, if any, should be mentioned clearly; otherwise, the rates will be treated as all inclusive. Statutory rates are subject to change and will be considered as may be fixed by the Govt.
10. Minimum annual turnover during the last 03years, ending 31st March of the previous financial year should be at least Rs.50.00 lakhs. However, MSE /Start-ups are exempted against valid certificate.
11. **The bidder must have registered office / workshop / factory at consignee state (Telangana) before date of this bid. Proof of rental agreement cannot be considered as office at consignee state.**
12. **Experience criteria:** Experience of having successfully completed 01 similar works during last 03years.
13. Definition of “similar work” should be clearly defined with specifications.
14. The successful bidder needs to deposit **Security Deposit of 5% of the Work Order** value within a week (07 Days) through Demand Draft / BG / FDR in favour of NIFT Hyderabad which will be refunded / returned without any interest after one year from the date of completion of the work with deduction, if any and as applicable.
15. The works should be completed within **6 weeks (including providing of sample units of each item)** from the date of receiving of Work Order failing which a penalty @ 0.5% of the order value per week will be imposed subject to a maximum of 10% of the Order value. However, delay due to any applicable / unforeseen reason, viz. natural calamity, non-availability of site etc., may / may not be considered as may be decided by NIFT Authorities.
16. All statutory obligations under various laws, imposed from time to time will be to be met by the contractor for which no extra payment shall be made to him. NIFT will no way be responsible for any default with regard to statutory obligations if any.



17. The quotes should be valid for at least 06months from the date of opening of the tender, however, for the successful bidder, the rates will be valid till completion of the job.
18. No payment shall be made in advance. The payment shall be made after commissioning of works and on the basis of certification by the concerned NIFT Official(s). TDS etc., if any and as applicable will be deducted during payment.
19. The quantity of items of work may vary and payment will be made based on actual.
20. NIFT shall not provide any mode of transport in respect of men or material required by the contractor for execution of the work.
21. Any query / clarification with respect to the tender (T&Cs, specification(s) etc.) may be cleared prior to submission of bid concerned NIFT official(s) may be contacted in this regard in between 10:00AM to 5:00PM on any working day (040-23115934, 23114436, e-mail: building.hyderabad@nift.ac.in). NIFT will not entertain or clarify any such query during post bid.
22. Works shall be executed at NIFT campus, Opp. Cyberabad, Hyderabad by the successful bidder with supervision of Estate Engineer.
23. The contractor should have a valid 11 KV and above license from Telangana Eelectrical Licensing Board or Ccentral government Eelectrical Licensing Board The Contractor should conduct on-site cable quality test and should submit copy of testing report
24. **After completion of work, the bidder must take necessary Clearances from Telangana Electricity Department and also co ordinate with the department for charging the cable.**
25. The tender is liable to be rejected if complete information is not given or if the particulars and data (if any) asked for in the schedule of the tender are not filled in correctly.
26. Tender shall be accompanied by the relevant documents including the following:
