- 1) The bidder should visit and inspect the service location and its surroundings before submitting a bid. The bidder is responsible for gathering all information necessary to prepare the bid, including site conditions, accessibility, facilities, and any other relevant factors. Any expenses incurred for visiting the service site at National Institute of Fashion Technology, Dharmashala, Kanool Post, Kannur, Kerala - 670 562 must be borne entirely by the bidder, and no reimbursement will be provided by the institute.
- 2) The % (percentage) of service charge should comprises of all estimated expenditure payable GeM authority (registration charges, Annual milestone charges, etc., further, financial bid and the percentage quoted should match to the quoted amount in the format requested in Annexure II), GST, TDS, any other statutory deduction and agency expenditure.
- 3) The agency must have own office in Kerala for immediate response. No exception will be made in this clause.
