Department/PSUs/MNCs Reputed Academic Institutes/Organizations.

#### Terms & Conditions:

- 1) Please read the terms & conditions carefully before filling up the document. Incomplete tender documents will be rejected.
- 2) Conditional or offline tender will not be accepted or the condition(s) may not be considered.
- 3) The Financial Bids of technically qualified bidder only will be opened.
- 4) Even after qualifying in technical bid, the financial bid may not be accepted if found not in order.
- 5) 'Credential' issued by the officer not below the rank of Exe. Engineer of the deptt./ sector will be accepted.
- 6) In case of L-1 is more than one, the selection criteria [viz. the past performance, experience, turnover, etc.] would be at the discretion of NIFT. The decision of NIFT, in this regard and for

selection of successful bidder in such situation, will be final in all respect and will be binding on all the tenderers.

- 7) Lowest bid may not be the only criteria for selection and NIFT is not bound to issue work order to the agency being the 'L-1' bidder; weightage/ preference will also be given to the other factors, viz. previous experience, quality of service, number of client, yearly turnover, etc. to select the agency to award the work and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the tenderers.
- 8) All Taxes & other charges, if any, should be mentioned clearly; otherwise, the rates will be treated as all inclusive. Statutory rates are subject to change and will be considered as may fixed by the Govt.
- 9) Minimum average annual financial turnover during the last 3 years, ending 31<sup>st</sup> March of the previous financial year, should be at least **Rs. 60 lakh**.
- 10) The tenderer must have at least 3 years of experience in the relevant field and execution of similar kind of works in the Govt., PSU, reputed MNCs/ organizations etc. The relevant certificate must be enclosed with the bid document.
- 11) The bidder needs to deposit the EMD of Rs. 60,000/- in shape of DD in Favor of **National Institute of Fashion Technology** payable at **Bhubaneswar**.
  - i. This amount is interest free and will be returned to the unsuccessful bidder after finalization of the Contract within 30 days.
  - ii. The firms registered with NSIC, MSME and start-up if any, are exempted from payment of Earnest Money Deposit (EMD). The valid proof should be enclosed along with the bid document.
- 12) The successful bidder needs to deposit **Security Money** of **5%** of the Work Order value through DD/BG/FDR in favour of **National Institute of Fashion Technology** payable at **Bhubaneswar** within 15 days of receipt of purchase order. No interest shall be paid on such security deposit and it shall be returned after 3 months of expiry of the warranty of the license, subject to clearance of all dues by the contractor.
- 13) The works should be completed within **04 weeks** from the date of receiving of Work Order failing which a penalty @0.5% of the order value per week will be imposed subject to a maximum of 10% of the Order Value. However, delay due to any applicable/ unforeseen reason, viz. natural calamity, non-availability of site etc., may/ may not be considered as may be decided by NIFT Authority.
- 14) The bid specific Authorization form from the OEM for the must be attached as certificate.
- 15) The bidder/OEM service will provide support within 24 hours after a case is logged or a complaint is lodged at NIFT, Bhubaneswar. If require the bidder/ OEM is required to visit NIFT Bhubaneswar.
- 16) The Certificate, documentation related to Firewall renewal and other aspect (requested by IT department NIFT Bhubaneswar) has to be provided by the bidder.
- 17) Timely Servicing/rectification of Issue/ service during the period (i.e. 3 Years): After having been notified of the defects/service requirement during the period (i.e. 3 Years), Seller/OEM has to

complete the required Service / Rectification within 2 days time. If the Seller/OEM fails to complete service / rectification with defined time limit, a penalty of 1% of the Yearly subscription (after calculation) shall be charged as penalty for each day of delay from the Seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG) or necessary action may be taken.

- 18) Work is to be completed satisfactorily on the entire satisfaction of IT department of the NIFT, Bhubaneswar.
- 19) The subscription will be provided within 20 days after placing the Work Order.
- 20) The renewed license shall be valid for a period of 3 Years from the date of activation at NIFT Bhubaneswar.
- 21) The vendor/OEM shall provide 24x7 technical support during the license period. Support must include remote troubleshooting and, if required, on-site assistance.
- 22) The renewed license must be fully compatible with the existing firewall hardware i.e. Sophos XGS 4300.
- 23) The firewall appliance must be covered under valid hardware warranty/support. In case of hardware failure, replacement should be provided Immediately within 3 days, if the Seller/OEM fails to provide the replacement a penalty of Rs. 1000/- shall be charge for each day from seller.
- 24) The renewal must include: Regular Sophos Firewall updates, Security patches and bug fixes, Latest threat intelligence and signature updates.
- 25) All statutory obligations under various laws, imposed from time to time will have to be met by the contractor for which no extra payment shall be made to him. NIFT will no way be responsible for any default with regard to statutory obligation, if any.
- 26) The quotes should be valid for at least 6 months from the date of opening of the tender however, for the successful bidder the rates will be valid till completion of the job.
- 27) The subscription should include network protection, web protection, ndr essentials for firewall, zero-day protection, central orchestration, DNS protection, enhance support, email and web server protection.
- 28) An office of the bidder must be located in the state of Consignee i.e. Bhubaneswar or Cuttack. Documentary evidence to be submitted in the bid document.
- 29) No payment shall be made in advance. The payment shall be made after commissioning of works and on the basis of certification by the concerned NIFT Official(s). TDS etc., if any and as applicable, will be deducted during payment.
- 30) The quantity of items of work may vary and payment will be made based on actual.
- 31) NIFT shall not provide any mode of transport in respect of men or material required by the contractor for execution of the work.
