3. Guidelines for submission of E-Tender through CPP - portal.

- 3.1 Applications to this tender will be accepted only through the **on-line Central Procurement Portal (CPP)** only. No other mode of application will be considered & application will not be accepted
- 3.2 Tender documents details are also available for viewing **and download for reference** on the NIFT official website <https://www.nift.ac.in/bengaluru/tenders>.
- 3.3 The Service provider should ensure that it complies with the requirements as per works indented before participating in the tender.
- 3.4 TECHNICAL BID - The technical bid must contain all the technical information (the documents should also be scanned and uploaded in CPP portal and the originals or self-attested (as details in Check list - Annexure -I) should reach this office within two working days after the last date of online submission of Bids)**
- Technical Bid shall contain: - Technical Bid document should be presented in the order as per the Checklist requirements requested in - **Annexure- I** and should submit the self-attested copy of all the document as requested in **Annexure- I** to prove eligibility for the tender

- xii. Specify whether you are registered with KPDW-II/CPWD-III/local Municipal Authority Class-I / any other legal entity /Govt. organization/ autonomous bodies etc. If “YES”, copy of the “Registration Certificate” to be enclosed.
- xiii. If the company is under partnership - copy of partnership deed for partnership firm or Memorandum of understanding (MOU) and Article or Association (AOA) including Certificate of Incorporation for change in name, if any, for limited/ private limited company.
- xiv. Any other detail/ confirmation asked in specifications.
- 3.5 No interest shall be paid on the EMD and the EMD shall be forfeited in case the selected/ successful bidder does not accept the contract order or unable to execute the work.
- 3.6 The EMD of unsuccessful bidders will be refunded within a month after on award of the contract.
- 3.7 Tenderers who satisfy the technical conditions stipulated in the tender document and who have enclosed all the documents (as listed Annexure - I) required will alone be considered as qualified Tenderers and alone will be considered for “Opening the Financial Bid” and for the items mentioned in Financial Bid the lowest price quoted is the general criterion for selection.
- 3.8 If there is one or more L1 offers found in Financial Bid, the decision of NIFT authority is final (Preference will be given to previous performance with Local service providers)

3.9 Technical evaluation, eligibility and preference:

- Service provider should have registered office or Sub registered office at Consignee state (KARNATAKA) before date of NIT. Proof of Rental agreement cannot be considered for office at Consignee state
- Preference will be given to service provider with experience in any services at NIFT Centres, and/ or with reputed institutes (like / IIT/ NIT/ NID or any other National Importance educational institution and/or service provider) and/ or with State /Central Government/ PSU/ statutory bodies/Autonomous bodies etc.,
- Contractor/Company should be registered with KPDW-II/CPWD-III/local Municipal Authority Class-I and experienced in same nature of work.
- Even after qualifying in technical bid, the Price bid may not be accepted if found not in order.
- The bid shall remain valid for 120 days from the date of opening of the Price Bid. Validity beyond 120 days from the date of opening shall be on mutual consent
- Bidders should provide the details in the Technical Bid such as company profile, details of all work experience, copy of purchase order/ work completion certificate, Company Registration proof of KPDW-II/CPWD-III/local Municipal Authority Class-I, etc. if any, of quoted works proposed for providing to NIFT, copy of the work order for similar kind of work. - 3.10 No tenderer shall be allowed to withdraw the tender rates after opening of the tender. If any tenderer withdraws the rates the EMD amount deposited by the service provider shall be forfeited and shall be disqualified from participating in any future tenders of the Institute.
- 3.11 Rates should be offered unconditionally and if rates are submitted with any condition the tender shall be rejected.
- 3.12 Tenderer shall have to quote in financial bid proforma selected Excess or Less and entered the Numeric value up to two decimals in CPP excel Percentage BOQ format. The quote tender vales in inclusive of all taxes.
- 3.13 The tenderer must visit the site and make themselves conversant with site and site conditions before submitting the bid.
- 3.14 The bidder shall not be black listed by any Govt./Semi Govt./PSU. A self-certificate in this regard shall be enclosed.

- 3.15 The bidder shall be free from the encumbrance and there shall not be any vigilance case/ CBI case/ Court Case pending against him. A self-certificate in this regard shall be enclosed.
- 3.16 Having ISO certification will be an added qualification for preference.
- 3.17 Tender will be rejected if wrong/false information provided (or) fails to submit necessary information as requested in Annexure -I
- 3.18 Price Bids of technically qualified bidders only will be opened.
- 3.19 In case of L-1 is more than one, the selection criteria (viz. the past performance, experience, turnover, etc.) would be at the discretion of NIFT. The decision of NIFT, Bengaluru in this regard and for selection of successful bidder in such situation, will be final in all respect and will be binding on all the Bidders. Lowest bid may not be the only criteria for selection and NIFT is not bound to issue work order to the agency being the 'L-1' bidder; weightage/ preference will also be given to the other factors such as in Price Bid filled detail is not in order, any difference of technical details given by the Bidder in the Technical Bid and price Bid etc., and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the Bidders.

4. INSTRUCTIONS TO TENDERERS:

The tenderers submitting their bid under this tender document are requested to strictly abide by the following instructions, failure to which may lead to rejection of tender document. The tenderers are requested to follow the below mentioned instructions:

- 4.1 **The tender document is not transferable to any other person.**
- 4.2 Submission of bid in on line portal will generally treated as acceptance of all the terms and condition in the tender document.
- 4.3 The acknowledge tender document should be the same as according to the prescribed formats. Modifications/ Rewording of formats shall not be acceptable.
- 4.4 Cost involved in visiting of NIFT Bengaluru Campus or any query related to tender or attending the tender opening meeting, arrangements for the demonstration/ presentation etc. shall be borne by the bidder.
- 4.5 The site visit can be seen on any working day during office hours by prior permission.
- 4.6 The Competent Authority of NIFT, reserves the right to accept or reject any tender or all tenders without assigning any reason.
- 4.7 Subletting - contract shall not be assigned or sublet to another party.
- 4.8 The successful firms/ agencies/ contractors will be intimated and contract agreement will be entered into initially for a period of one year.
- 4.9 The contract may be terminated at any stage solely at the discretionary power NIFT without assigning any reason
- 4.10 Rates quoted shall be firm and fixed throughout the contract period and are inclusive of cost of manpower, material, machinery, tools and plant etc., all taxes (including Goods and Service Tax), duties and levies, insurance etc. no escalation of whatsoever nature shall be payable.
- 4.11 The successful bidder shall make a security deposit as per notification in CPP portal (on the work order value) and furnish the same for the proper fulfillment of the Contract The same will be returned after successful completion of the contract after 60 days, without any interest. and shall also execute an Agreement for the work on Rs.500 non-judicial Karnataka Stamp Paper in the format given by NIFT BENGALURU

- 4.12 The qualified contractor/ firm/agency should submit copies of certificates of PF Code No. and registration under Contract Labour (Abolition / Regulation) Act, 1970 along with Tender documents and with each RA bill and the Contractor having no such registration number, the necessary deductions will be made as per the Govt. Rules.
- 4.13 The Contractor shall comply with all existing Central Govt. labour legislation and Acts, such as Contract Labour Regulation Act, Workmen's Compensation Act, Minimum Wages Act, Payment of Wages Act, Provident Fund Act, ESI Act etc., For any lapse or breach on the part of the contractor in respect of non-compliance of any Labour legislation in force during the validity of the contract, the Contractor would be fully responsible and would indemnify the Institute, in case the Institute is held liable for the lapse on the part of the Contractor, in this regard
- 4.14 The provision of Goods and Service Tax (GST) as applicable from time to time will be binding on the tenderer and proof of payment of GST will be provided by the tenderer along with their bill.
- 4.15 NIFT reserves the right to change the quantity/drop any item or part thereof/change in the scope of work and the bidder shall have to supply the items and execute the work at the same Rate per unit as mentioned in their Price bid.
- 4.16 The Director, NIFT Bengaluru reserves the right to accept the whole tender or any part thereof or reject all the tenders, in the interest of the NIFT so require, without assigning any reasons whatsoever and to waive any minor discrepancy in the tenders received.
- 4.17 If complete information is not given (or) if the particulars and data are not filled in correctly (or) not as specified in the Tender document and may render the bid non-responsible and liable to be rejected.
- 4.18 The Committee constituted by the Director, NIFT, Bengaluru shall have the right to verify the particular furnished by bidder. Those technically qualified bids will only be considered for price evaluation (Price Bid). Price should not be quoted with technical bid; otherwise, the tender will be rejected without any correspondence. Decision of the Director, NIFT Bengaluru on the eligibility for qualifying technical bids shall be final and no representation shall be considered in this regard

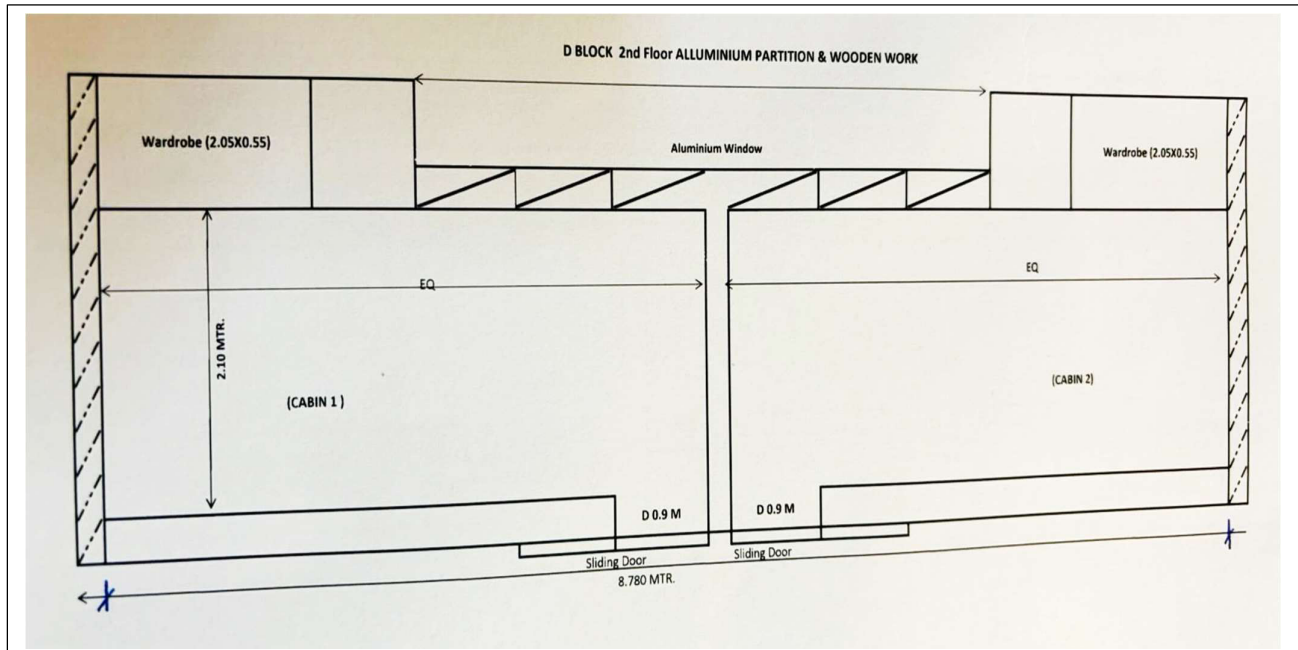
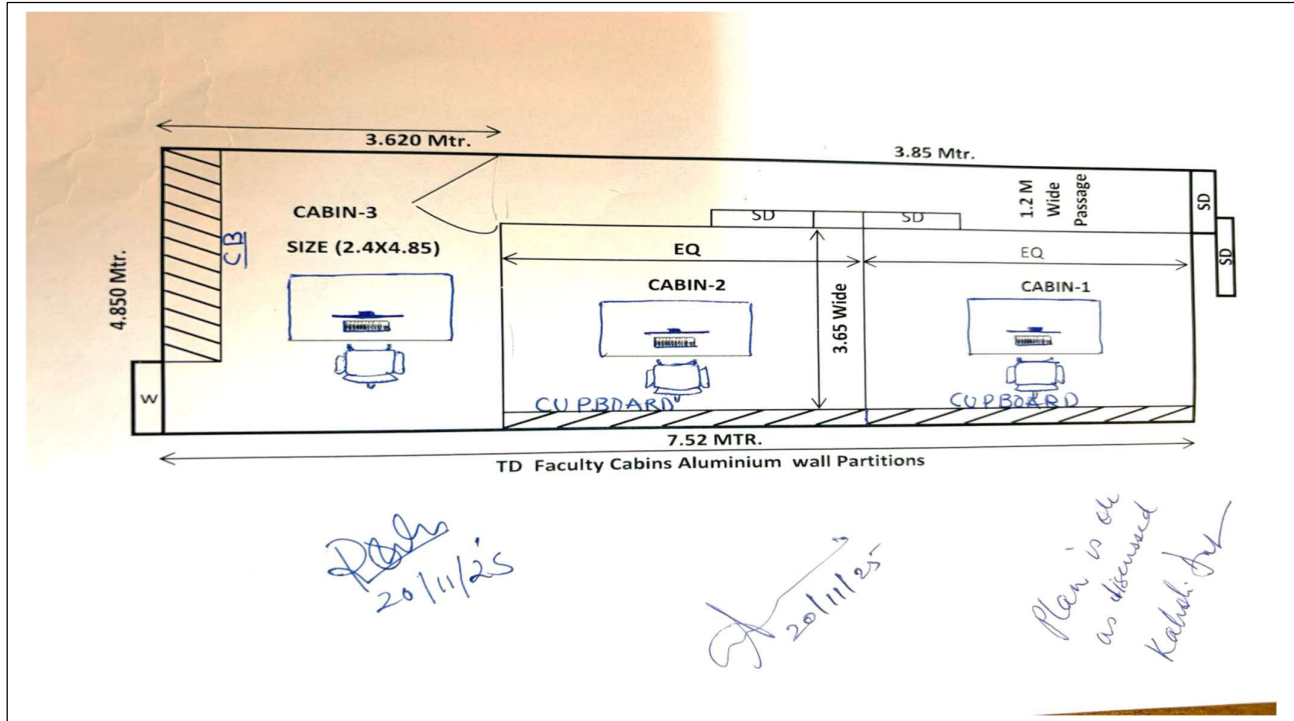

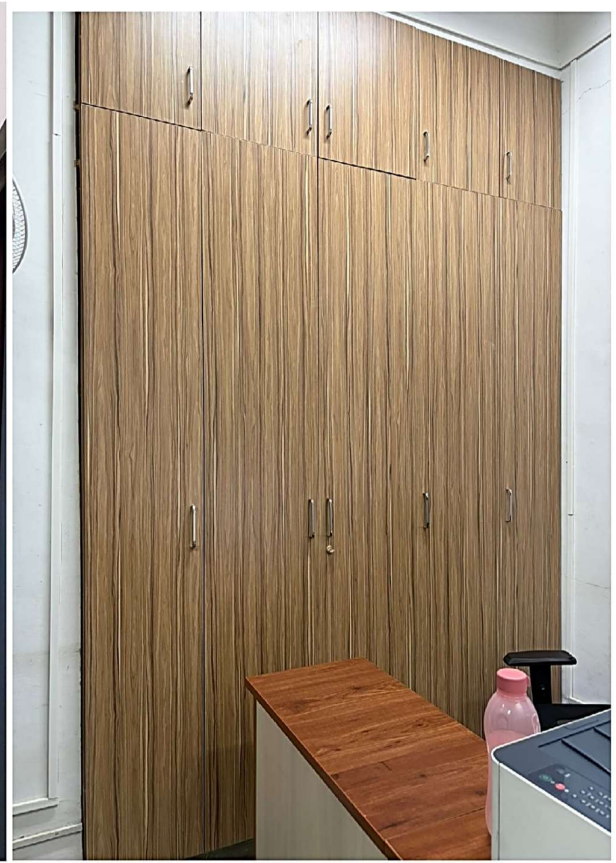
