NIFT provides fashion business education across the country through its network of 18 centers. It provides four years undergraduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and short duration education program to address the specialized needs of professional and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Daman, Delhi, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, Panchkula, Patna, Rae Bareilly, Shillong and Srinagar.

- 3.1 Applications to this tender will be accepted only through the on-line Central Procurement Portal (CPP) only. No other mode of application will be considered & application will not be accepted

- 3.3 The Service provider should ensure that it complies with the requirements as per works indented before applying for the tender.

- 3.7 No interest shall be paid on the EMD and the EMD shall be forfeited in case the selected/ successful bidder does not accept the contract order or unable to execute the work.
- 3.8 The EMD of unsuccessful bidders will be refunded within a month after on award of the contract.
- 3.9 Tenderers who satisfy the technical conditions stipulated in the tender document and who have enclosed all the documents required (as listed Annexure - I) will alone be considered as qualified Tenderers and alone will be considered for **"Opening the Financial Bid"** and for the items mentioned in Financial Bid the lowest price quoted is the general criterion for selection.
- 3.10 If there is one or more L1 offers found in Financial Bid, the decision of NIFT authority is final (Preference will be given to previous performance with Local service providers)
- 3.11 Technical evaluation, eligibility and preference:**
- Service provider should have registered office or Sub registered office at Consignee state (KARNATAKA) Proof of Rental agreement cannot be considered for office at Consignee state.
 - **If there is one or more L1 offers found in Financial Bid, the decision of NIFT authority is final (to give Preference Local service providers or to fix the criteria by the authority)**
 - Preference will be given to service provider with experience in any services at NIFT Centers, and/ or with reputed institutes (like / IIT/ NIT/ NID or any other National Importance educational institution and/or service provider) and/ or with State /Central Government/ PSU/ statutory bodies/Autonomous bodies etc.,

- Contractor/Company should be registered with KPDW/CPWD/local Municipal Authority and experienced in same nature of work.
 - The bidder should have at least three-year experience (as on 31.03.2025) in the field of **Supply and installation of Furniture/ Repairing of Furniture / wooden & MS work** in civil construction work.
 - The Bidder should have successfully completed similar works during last 03 (three) years ending last day of month previous to one in which applications are invited should be either of the following: - The Bidder must have successfully executed / completed at least one single order of 80% of the Estimated Bid Value or 2 orders each of 50% of the Estimated Bid Value or 3 orders each of 40% of the Estimated Bid Value for similar service(s) in last three years to any Central / State Govt Organization / PSU / Public Listed Company. Copies of contracts / work orders and documentary evidence of successful execution / completion in support of Past Experience of Similar Services along with names, address and contact details of clients shall be uploaded with the bid for verification by the Buyer
 - Note: - Similar works/ Same nature of work means – **Supply and installation of Furniture/ Repairing of Furniture / wooden & MS work in civil construction** “in Residential building/Housing building complex/ Apartments/ Commercial Building/ (Colleges/Hotels/mall/hospital in civil construction etc.,
 - The bidder should have a valid registration/ license with the appropriate registering/ licensing authority for supplying work force.
 - The bidder should have a valid registration under EPF &ESI Rules.
 - The bidder should have valid PAN and GST Registration
 - The bidder should submit undertaking & Acceptance in letter head in original stationery along with the Tender document in the prescribed format **Enclosure-II**.
 - All the details in **Annexure-I** should be submitted by the bidder
 - The Bidder shall not be under a declaration of ineligibility for corrupt or fraudulent practices or blacklisted by any of the Government agencies.
 - Average Annual Financial turnover for any 03 years during the last 05 years, ending 31st March 2024 (i.e. 2019-20, 2020-21, 2021-22, 2022-23 & 2023-24) should be at least **Rs.10,00,000/- (Rupees Ten lakhs only) and each year not less than Rs.8,00,000/- (Rupees Eight lakhs only) (copies of audited balance sheets certified by CA to be submitted)**
(Minimum Turnover figures and limits are as stipulated by CVC in the prequalification criteria of Tender Document vide CVC Office Memorandum No.12-02-1-CTE-6, dated 17th December 2002).
 - The catalogue/ Brochure for the Furniture quoted by the vendors should be enclosed along with technical bid
- 3.12 No tenderer shall be allowed to withdraw the tender rates after opening of the tender. If any tenderer withdraws the rates the EMD amount deposited by the service provider shall be forfeited and shall be disqualified from participating in any future tenders of the Institute.
- 3.13 Rates should be offered unconditionally and if rates are submitted with any condition the tender shall be rejected.
- 3.14 Tenderer shall have to quote item wise rates; consolidated rates shall not be considered and tender shall be liable to be rejected out rightly.

- 3.15 The tenderer must visit the site and make themselves conversant with site and site conditions before submitting the bid.
- 3.16 The bidder shall not be black listed by any Govt./Semi Govt./Private Institution. A self-certificate in this regard shall be enclosed.
- 3.17 The bidder shall be free from the encumbrance and there shall not be any vigilance case/ CBI case/ Court Case pending against him. A self-certificate in this regard shall be enclosed.
- 3.18 **FINANCIAL BID (upload the BOQ)** (Quote for all the indented items is mandator and should be submitted in the BOQ format)
 - As the process of bid submission is through CPPP website. A separate excel sheet generated known as Bill of Quantity (BOQ) for submission of Financial Bid through online by selecting the appropriate higher or lower percentage in the specified area
 - Please select Excess (+) for providing higher side or select Less (-) for providing lower side quote from the select box column 5 and enter the valid percentage rate in the column 6 comparing to the estimate provided in column 6 and check the quoted amount appeared column 7 in figure and column 8 and row 17 in worlds and validate the BOQ by selecting the validate option from left top and upload the same in the financial bid both Excel form and PDF with seal and signature in the tender. Financial Bid must be submitted online in the prescribed BOQ format only.
 - Bid will be rejected in case submitted in any other format or with the Technical/ tender document. Indicative rate list at BOQ (Financial Bid – Annexure -II) must be compulsorily with percentage indicate excess/ Less of the work mentioned in the BOQ Enclosure – VI and percentage filling in Annexure -II.

4. **INSTRUCTIONS TO TENDERERS:**

The tenderers submitting their bid under this tender document are requested to strictly abide by the following instructions, failure to which may lead to rejection of tender document. The tenderers are requested to follow the below mentioned instructions:

- 4.1 The tender document is not transferable to any other person.
- 4.2 Submission of bid in on line portal will generally treated as acceptance of all the terms and condition in the tender document.
- 4.3 The acknowledge tender document should be the same as according to the prescribed formats. Modifications/ Rewording of formats shall not be acceptable.
- 4.4 Cost involved in visiting of NIFT Bengaluru Campus or any query related to tender or attending the tender opening meeting, arrangements for the demonstration/ presentation etc. shall be borne by the bidder.
- 4.5 The site visit can be seen on any working day during office hours by prior permission.
- 4.6 The Competent Authority of NIFT, reserves the right to accept or reject any tender or all tenders without assigning any reason.
- 4.7 Subletting - contract shall not be assigned or sublet to another party.

- 4.8 The successful firms/ agencies/ contractors will be intimated and contract agreement will be entered into initially for a period of one year.
- 4.9 The contract may be terminated at any stage solely at the discretionary power NIFT without assigning any reason
- 4.10 Rates quoted shall be firm and fixed throughout the contract period and are inclusive of cost of manpower, material, machinery, tools and plant etc., all taxes (including Goods and Service Tax), duties and levies, insurance etc. no escalation of whatsoever nature shall be payable.
- 4.11 The successful bidder shall make a security deposit as per notification in CPP portal (on the work order value) and furnish the same for the proper fulfillment of the Contract The same will be returned after successful completion of the contract after 60 days, without any interest. and shall also execute an Agreement for the work on non-judicial Karnataka Stamp Paper in the format given by NIFT BENGALURU
- 4.12 No advance payment will be made, running bills may be paid on recommendation basis by the building section. Full and final payment will be made on satisfactory completion of the work, which will have to be certified by the Engineer-in-Charge, NIFT, Bengaluru.
- 4.13 The qualified contractor/ firm/agency should submit copies of certificates of PF Code No. and registration under Contract Labour (Abolition / Regulation) Act, 1970 along with Tender documents and with each RA bill and the Contractor having no such registration number, the necessary deductions will be made as per the Govt. Rules.
- 4.14 The Contractor shall comply with all existing Central Govt. labour legislation and Acts, such as Contract Labour Regulation Act, Workmen's Compensation Act, Minimum Wages Act, Payment of Wages Act, Provident Fund Act, ESI Act etc., For any lapse or breach on the part of the contractor in respect of non-compliance of any Labour legislation in force during the validity of the contract, the Contractor would be fully responsible and would indemnify the Institute, in case the Institute is held liable for the lapse on the part of the Contractor, in this regard
- 4.15 The provision of Goods and Service Tax (GST) as applicable from time to time will be binding on the tenderer and proof of payment of GST will be provided by the tenderer along with their bill.
- 4.16 Award of work:**
- The selection of the agency will be at the sole discretion of the NIFT who reserves its right to accept or reject any or the all proposals without assigning any reason.
 - The contract for **Repair works of Hostel Furniture's in BOQ Basis at NIFT Bengaluru, campus** shall be awarded to the qualified responsive tenderer who has quoted lowest.
 - Upon evaluation of offers the notification on award of contract will be intimated to the successful tenderer.

5 **SCOPE OF WORK:**

- The Successful Bidder shall be responsible to complete the works in all respects and satisfactory performance of complete system.
- The Successful Bidder shall be responsible to complete the works towards **Repair works of Hostel Furniture's in BOQ Basis at NIFT Bengaluru, campus** as per item specifications of Hostel blocks (E&F) Ground to 5th floor and other areas of the campus as per instructions of E/I.
- Time allotted for completion of this work is only 15 days
- Work Including Providing & Installation of hardware material/accessory as per approved makes and specification provided in tender documents.
- Work including Providing and fixing ISI marked flush door shutters conforming to IS: 2202 (Part I) non-decorative type, core of block board construction with frame of 1st class hard wood and well matched commercial 3 ply veneering with vertical grains or cross bands and face veneers on both faces of shutters: 35 mm thick including ISI marked Stainless Steel butt hinges with necessary screws. Including removing of existing door shutter etc complete as per direction of E/I.
- Providing and fixing table top up to 1.00 sqm. by using 18 mm thick commercial/block ply wood with 1mm thick lamination at top, Minor repairs to existing Almirah, cot, Table like hook fitting, replacing/repairing locking system, bend removing, door shutter repairing, small touch up painting, handle tightening, screw damaged locker round/long handle, main door handle replacing with new one tightening, cot nut bolt tightening, welding, drawer setup, nobe fixing, bushes fixing etc., complete including cost of labour materials etc. Complete, as per direction of E/I. Changes in the constitution of the firm, if any shall be immediately notified to the employer, in writing and approval obtained for continued performance of the contract.
- c) i) "Contract" means these conditions, the Specification, the Bill of Quantities, the Tender, the Letter of acceptance, the Contract Agreement (if completed) and such further documents as may be expressly incorporation in the letter of Acceptance or Contract Agreement (if completed).
- ii) "Specification" means the specification of the Works included in the Contract and any modification thereof.
- iii) "Drawings" means all the completion drawings, calculations and technical information of a like nature provided by the Engineer to be Contractor under the Contract and all drawings, calculations, samples, patterns, models, Repair and Repair and Maintenance manuals and other technical information of a like nature submitted by the Contractor and approved by the Engineer.
- iv) "Bill of Quantities" means the priced and completed bill of quantities forming part of the tender.
- v) "Tender" means the Contractor's priced offer to the Employer for the execution and completion of the works and the remedying of any defects therein in accordance with the provisions of the Contract, as accepted by the Letter of Acceptance. The word Tender is synonymous with "Bid" and the words "Tender Documents" with "Bidding Documents".
- vi) "Letter of Acceptance" means the formal acceptance of the tender by NIFT.
- vii) "Contract Agreement" means the contract agreement (if any) referred to in Sub- Clause.
- viii) "Appendix to Tender" means the appendix comprised in the form of Tender
- d) (i) "**Commencement Date**" means the date upon which the Contractor receives the notice to commence the works.
- (ii) "**Time for completion**" means the time period for which the contract of Repair & operation and Maintenance has been awarded by the employer to the contractor.
- e) "**Taking over Certificate**" means a certificate issued by employer evidencing successful completion of the awarded work.
- f) i) "**Contract Price**" means the sum stated in the Letter of Acceptance as payable to the Contractor for the execution and completion of the Works and the remedying of any defects therein in accordance with the provisions of the Contract.
- ii) "**Retention Money**" means the aggregate of all monies retained by the Employer.
- g) i) "**Works**" means the Permanent Works and the Temporary Works or either of them to be executed in accordance with the contract.
- ii) "**Site**" means the places provided by the Employer for Repair and Maintenance of NIFT Campus.
- iii) "**Cost**" means all expenditure properly incurred or to be incurred, whether on or off the site, including overhead and other charges but does not include any allowance for profit.
- B. Engineers Duties and Authority:** The Engineer shall carry out the duties specified in the Contract.
- C. Custody and Supply of Drawings and Documents:** The Drawings shall remain in the sole custody of the employer/ Engineer, but copies as required thereof as per availability in the record shall be provided to the Contractor free solely for the purpose of this contract.

- D. Sufficiency of Tender:** The Contractor shall be deemed to have based his Tender on the data made available by the employer and on his own inspection and examination of this site conditions.
- E. Contractor's Employees:** The Contractor shall provide on the site qualified and experienced technical staff in connection with the Repair and Maintenance of the Works and the remedying of any defects therein. The minimum staff shall be as per description of work mentioned.
- F. Engineer at Liberty to object:** The Engineer shall be at liberty to object to and request the contractor to remove forthwith from the Works any person provided by the contractor who, in the opinion of the Engineer, misconducts himself, or is incompetent or negligent in the proper performance of his duties, or whose presence on Site is otherwise considered by the Engineer to be undesirable, and such person shall not be again allowed upon the Works without the consent of the Engineer. Any person so removed from the works shall be replaced as soon as by a qualified person approved by the Engineers.
- G. Safety, Security and Protection of the Environment:** The Contractor shall, throughout the execution and completion of Works and the remedying of any defects therein:
- Have full regard for the safety of all persons entitled to be upon the Site and keep the Site (so far as the same is under his control) and the Works (so far as the same are not completed or occupied by the Employer) in an orderly state appropriate to t avoidance of danger to such persons, and
 - Provide and maintain at his own cost all lights, guards, fencing, warning signs and watching, when and where necessary or required by the Engineer or by any duly constituted authority for the protection of the Works or for safety and convenience to the public or others, and
 - Take all reasonable steps to protect the environment on and off the Site and to avoid damage or nuisance to persons or to property of the public or others resulting from pollution, noise or other causes arising as a consequence of his methods or Repair.
- H. Damage to Persons and Property:** The sole responsibility lies with the contractor of the persons employed by his agency/ firm against all losses and claims in respect of:
- Death of or injury to any person, or
 - Loss or damage to any property (other than the Works):
Which may arise out of or in consequence of the Repair and Maintenance of the works and the remedying of any defects therein, and against all claims, proceedings, damages, costs, charges and expenses whatsoever in respects thereof.
- I. Accident or injury to Workmen:** NIFT shall not be liable for or in respect of any damages or compensation payable to any workman for death or injury resulting from any act or default of the contractor. The Contractor shall indemnify and keep indemnified the Employer against all such damages and compensation and expenses whatsoever in respect thereof or in relation thereto.
NIFT shall not be liable for or in respect of any damages or compensation payable to any workman under Compensation – Act for death or injury resulting from any act or default of the contractor. The contractor shall indemnify and keep indemnified the NIFT against all such damages and compensation and expenses whatsoever in respect thereof or in relation thereto.
- J. Evidence and Terms of Insurance:** The Contractor shall take out appropriate insurance to cover his work and workers and staff employed by him fully. The contractor shall provide evidence to the Engineer/ Employer as soon as practicable after the respective insurance has been taken out but, in any case, prior to the start of work at the Site that insurance required under the Contract have been affected.
It shall be the responsibility of contractor to notify the Insurance Company of any change in the nature and extent of the works and to ensure the adequacy of the Insurance cover at all times during the period of contract.

- K. Compliance with Statutes, Regulations:** The Contractor shall confirm in all respects, including by the giving of all notices and the paying of all fees, with the provision of:
- Any National or State statute, Ordinance, or other Law, or any regulation, or bye-law of any local or other duly constituted authority in relation to the execution and completion of the Works and the remedying of any defects therein, and
 - The rules and regulations of all public bodies and companies whose property or rights are affected or may be affected in any way by the Works, and the contractor shall keep the Employer indemnified against all penalties and liability of every kind for breach of any such provision.
 - Any changes required for approval due to revision of the local laws.
- L. Time for Completion:** The repair and Maintenance work shall be for a period of one year or as mentioned in the letter of commencement and shall start from the date of issue of letter to commencement and shall stand terminated after the expiry of one year or for the period as stipulated in the accepted contract agreement. The Repair and Maintenance contract may be extended on the written mutual consent of both NIFT and Contractor for a further period of two years. However, NIFT reserves the right to terminate the Repair and Maintenance contract by giving 15 days' notice period at any time during the currency of the contract if the services of the agency are not found satisfactory as per the opinion of NIFT or his representative for which, no claims or compensation shall be entertained by the NIFT.
- M. Extension of Time for Completion:** The Repair and Maintenance contract may be extended on the written mutual consent of both NIFT and Contractor for a further period of one year. However, NIFT reserves the right to terminate the Repair and Maintenance contract by giving notice period of 15 days' at any time during the currency of the contract if the services of the agency are not satisfactory as per the opinion of employer or its representative
- N. Defect Identification and its rectifications:**
- The Contractor shall immediately attend the defects and complaints noticed at site. The Contractor shall provide and develop a system for regular Repair and Maintenance of all the services which includes defects identifications and its immediate rectification so, that services are not affected. It shall be the sole responsibility of the Repair and Maintenance agency that all the services are kept in functional condition round the clock during the currency of the contract.
 - Defect Liability period shall be 12 months from the date of the completion of work under BOQ measurable works. The contractor shall rectify at his own expenses any defect in the work carried out by him during this period. On failure of the contractor to do so, the same shall be completed by the employer at the risk and cost of the contractor.
- O. Contractor's Failure to Carry out Instructions:** In case of default on the part of the Contractor in carrying out defect rectification works, the Employer/ Engineer shall be entitled to employ and pay other persons to carry out the same and if such work, in the opinion of the Engineer, the Contractor was liable to do at his own cost under the Contract, then all the costs consequent thereon or incidental thereto shall be determined by the Engineer and shall be recoverable from the Contractor by the Employer, and may be deducted by the Employer from any payments due or to become due to the contractor.

- d) **Correction of Certificates:** The Engineer at his discretion for any Interim Payment Certificate make any correction or modification in any previous Interim payment Certificate which has been issued by him, and shall have authority, if any work is not being carried out to his satisfaction, to omit or reduce the value of such work in any Interim Payment Certificate.
- e) **Final Certificate:** Within 15 days after receipt of the Final Statement, and the written discharge, the Engineer shall issue to the employer (with a copy to the Contractor) a final Certificate stating:
 - The amount which, in the opinion of the Engineer, is finally due under the Contract, and after giving credit to the Employer for all amounts previously paid by the Employer and for all sums to which the Employer is entitled under the Contract.
- f) **Conciliation:** In the event of any dispute, the party shall use their best efforts to settle amicably all disputes arising out of or in connection with this contract or the interpretation thereof.
- g) **Default of Contractor:**
 - If the performance of the contract is not satisfactory and not corrected within 15 days of receiving notice, then employer shall be at liberty to terminate the contract and get the work executed through other means at the risk and cost of the Contractor.
 - In the event of termination of the contract, employer shall be at liberty to get balance work done at the risk and cost of the contractor and due payment of the contractor, if any, shall be released after the completion of whole of the works.
- h) **Arbitration:** Any dispute and differences relating to the meaning of the specifications, designs, drawings and instructions herein before mentioned and as to the quality of workmanship of materials used in the work or as to any other question, claim, right, matter or thing whatsoever in any way arising out of or relating to the contract, designs, drawings, specifications, estimates, instructions or these conditions or otherwise concerning the works or the execution or failure to execute the same whether arising during the progress of the work or after the completion or abandonment thereof in respect of which amicable settlement has not be reached shall be referred to the Sole Arbitrator to be appointed by NIFT. The work under the contract shall continue, during the Arbitration proceedings. The award of the Arbitrator shall be final, conclusive and binding on both the parties. The courts at NIFT Bengaluru shall have the exclusive jurisdiction in any case of any dispute between the parties.
