**NOTICE INVITING EXPRESSION OF INTEREST (E.O.I)**  
**(For providing counselling psychologist services to the students/faculty/officials of NIFT Delhi Campus)**

### 1. Introduction

The National Institute of Fashion Technology (NIFT) was established in 1986 and became a statutory institute under the National Institute of Fashion Technology Act, 2006 enacted by the Parliament of India. NIFT has a network of full-fledged campuses across the country and is a premier institution in the field of fashion education, catering to the human resource requirements of the textile, apparel, fashion and lifestyle industries.

To promote the mental health and emotional well-being of its students, faculty and staff, NIFT Delhi Campus provides professional counselling services through qualified mental health professionals.

In order to meet the immediate requirement of an experienced **Counselling Psychologist, Expressions of Interest (EOI)** are invited from eligible and experienced professionals (preferably Women Consultants) for engagement as a **Part-Time Visiting Counselling Psychologist** on a temporary contractual/retainership basis for providing counselling and psychological support services to the students, faculty and staff of NIFT Delhi Campus.

### 2. Essential Qualifications and Eligibility Criteria

The applicant should possess the following qualifications and experience:

- **M.A./M.Sc. in Clinical Psychology** from a UGC-recognized University; **OR**
  - **MBBS** with a recognized certification/course in Psychological Counselling and Therapy.
  - Preference shall be given to candidates holding a **Doctoral Degree (Ph.D./Psy.D.)** and/or those already engaged with Public Sector Undertakings (PSUs), Autonomous Bodies, Government Educational Institutions or similar organizations for comparable assignments.
  - Minimum **10 (Ten) years** of post-qualification experience in counselling, psychotherapy or clinical psychology.

### 3. Scope of Work and Responsibilities

The empaneled Counselling Psychologist shall visit NIFT Delhi Campus **three days a week for two hours each day**, and additionally whenever required by the Institute for specific assignments.

The Consultant shall be responsible for, but not limited to, the following:

- Provide confidential psychological counselling to students, faculty and staff.
- Offer counselling for emotional, behavioural and academic concerns, including anxiety, stress, depression, examination-related pressure, homesickness and adjustment issues.
- Assist individuals experiencing personal or interpersonal difficulties, including bereavement, relationship issues, family conflicts and other developmental or adolescent concerns.
- Provide psychological support and preliminary intervention in cases involving eating disorders, trauma, post-traumatic stress disorder (PTSD), panic disorders and other mental health conditions requiring professional attention.
- Conduct individual and group counselling sessions, awareness programmes, workshops and stress management sessions whenever required.
- Identify individuals requiring specialized psychiatric intervention and recommend referral to appropriate medical or mental health facilities.
- Maintain complete confidentiality of counselling records and ensure compliance with professional ethics.
- Submit periodic reports, without disclosing confidential personal information, whenever required by the Competent Authority.
- Perform any other counselling-related duties assigned by the Institute from time to time.

---

### 4. Appointment and Tenure

- The engagement shall be purely **temporary and contractual** in nature.
- The initial tenure shall be **one (01) year**.
- The engagement may be extended annually, subject to satisfactory performance and the requirements of the Institute, up to a maximum period of **three (03) years**.
- The engagement shall not confer any right for regular appointment or continuation beyond the approved tenure.

---

### 5. Remuneration

The Part-Time Visiting Counselling Psychologist shall be paid a **consolidated remuneration of ₹45,000/- (Rupees Forty-Five Thousand only) per month**.

No other allowances or benefits shall be admissible unless specifically approved by the Institute.

The selection process shall consist of:

- Scrutiny of applications; and
- Personal Interview.

Only shortlisted candidates shall be called for the interview. Candidates shall produce the original certificates and testimonials at the time of interview for verification.

## 7. Leave Eligibility

The Consultant shall be entitled to **08 (Eight) days of Casual Leave during a calendar year**, subject to prior approval of the Competent Authority.

## 8. How to Apply

Eligible and interested candidates shall submit their applications in the prescribed format (**Annexure–A**) along with self-attested copies of all relevant certificates and supporting documents.

Incomplete applications or applications received after the prescribed date shall be summarily rejected.
