Eligible and competent Building owners are requested to submit their offer in prescribed application form in sealed envelope. The application form along with other EOI details and document can be downloaded from the NIFT Daman website www.nift.ac.in/daman.

EOI duly filled in documents, complete in all respects should reach the office of the Purchase Department, NIFT Daman Campus.

Last date for submission of EOI is 26/05/2025 and received EoI will be opened on 27/05/2025 at 10 A.M.

ESSENTIAL FEATURES OF REQUIRED ACCOMMODATION

- 1. The capacity of Buildings should accommodate around 60 girls students.
- 2. The distance between NIFT Daman Campus and hiring building should be within 10KM.
- 3. Minimum number of rooms: 25. The hostel building is required to accommodate 2 or 3 students per room.
- 4. Dining Hall.
- 5. The accommodation should have well ventilated and airy rooms with habitable condition, hygienic environment, neat and clean.
- 6. Ample number of bathrooms, toilets and wash basins must be in good condition and hygienic for required No. of students on Twin/ Triple sharing.
- 7. Availability of Geyser electrical fitting facility bathrooms in hostel.
- 8. The adequate size of room should be filled with SUFFICIENT tube light/LED light, fans and wardrobe.
- 9. Cleaning of Rooms/bathrooms/ toilets maintained by owner on daily basis.
- 10. Availability of Mess Service
- 11. Bed, Almirah & table chair will be provided for every rrom by owner
- 12. The building should be near from public transport facility and primary medical facilities.
- 13. Internet connectivity/ Wifi facility.
- 14. Electricity and Potable Water for drinking, bathing and cooking, must be available round the clock.

- 15. All the sanitary and water supply installations connections must have been provided in the facility.
- 16. Electrical installation and fittings like power plugs, switches, charging points etc. must be in place.
- 17. In emergency power backup / generator facility should be available.
- 18. The building should have suitable provision and adequate space for running Mess for students.
- 19. The electricity & water supply service shall be provided by the owner at his own cost & expenses.
- 20. The Service provider/ Building owner must provide document of Sanctioned Electricity load.
- 21. No commercial activity other than the Hostel will be carried out on the leased premises.
- 22. Selected party shall be required to execute an agreement containing detailed terms & conditions with NIFT Daman, in accordance with the provisions of the law applicable.
- 23. The Agreement shall be signed for a period of 11 months initially. Performance of the service provider/ building owner will be reviewed on yearly basis and the contract may be extended for a further period of not more than 3 years on mutually agreed terms and conditions.
- 24. Building offered must be free from all encumbrances, claims and legal disputes etc.
- 25. The electricity and water supply lines / connection shall be provided by the owner at his own cost and expenses.
- 26. The property shall fall under the jurisdiction of Daman only.

The premises on offer will be shortlisted on the basis requirements of the NIFT Daman and such parties will be invited for settlement of rent along with other terms and conditions.

NIFT Daman will inspect the location & premises to check the suitability of the premises for NIFT Girl Hostel along with technical criteria.

At any time prior to the last date of submission of EOI's, NIFT may for any reason, whether at its own initiative or in response to a clarification requested by prospective bidders, modify the EOI document by issuing Corrigendum/addendum. Permission from Local authorities towards operating the hostel needs to be obtained by interested parties

Selection will be on the basis of minimum monthly rent plus GST.

NIFT Daman will sign an agreement with the selected party which must be mutually agreeable to both the parties.

The offers along with pictures of the rooms / building and approximate distance from NIFT Daman campus are to be submitted to the Purchase Department, National Institute of Fashion Technology, Daman.

- 2. NIFT will not accept applications which are received after the due date and time or due to postal delays.
- 3. PAYMENT: NIFT Daman will only be liable to pay fixed monthly charge, electricity on the basis of actual consumption on reimbursement basis. Payment will be made month wise on submission of bill and documents.
- 4. NIFT Daman will not be liable to pay any charge for the normal wear and tear of fittings and fixtures in the Building premises.
