#### **OFFICE MEMORANDUM**

Sub: Promotion of Associate Professors, NIFT to the post of Professors for the vacancy year 2019.

The Board of Governors, NIFT has considered and approved the recommendations of the Departmental Promotion Committee meeting held on 27.11.2018 as per the lists attached herewith. The DPC had been held under the Chairmanship of Mr Rajesh Shah, Chairman of the Board of Governors of NIFT in pursuance of the decision of the Board of Governors regarding promotion to the post of Professor in its 44<sup>th</sup> meeting on the 19<sup>th</sup> of September, 2018 and the ensuing OM dated 12.11.2018 regarding the Recruitment Rules to the post of Professor at NIFT. The DPC had recommended appointment of those Associate Professors who met the following criteria in line with the OM dated 12.11.18 –

- A. Among Associate Professors who had completed 7 years
  - a. All those who were regular PhD holders
  - b. All those who had submitted their PhD thesis
  - c. All those who had given certification that they would complete their PhD or submit their thesis by 1.1.2020 (subject to further certification from concerned guide or supervisor, that the thesis would be submitted on or before the cut off date of 1.1.2020)

And who either

- B. had at least one outstanding APAR for the time zone of consideration, or
- C. did not have outstanding APAR, but whose student feedback was consistently 60% or above in all subjects in all parameters under examination, and the qualitative response was seen to be generally positive across semesters.
- 2. Accordingly, the officers found eligible for promotion as per Annexure —I are hereby promoted to the post of Professor, NIFT. The Associate Professors so promoted shall be on probation for a period of one year from the date of assumption of charge as Professor. The pay will be fixed as per the provisions of FR 22(I)(a)(1) by the respective Campuses and a copy of the joining report and order of pay fixation be forwarded to HO for records.
- 3. Of the list, the Associate Professors who have registered for PhD and have not yet submitted the thesis (Annexure-II), but have given undertaking to submit thesis or acquire the same on or before 01.01.2020 are required to provide the details (name, address and contact no.) of their respective Supervisor/Guide at e-mail id: <a href="mailto:establishment2.ho@nift.ac.in">establishment2.ho@nift.ac.in</a> urgently by 4.1.2019 in order for this office to take confirmation of completion of PhD/thesis submission by 1.1.2020. Their order of promotion will come into effect only on timely receipt of such confirmation.
- 4. The inter-se Seniority shall be maintained subject to the condition of completion of PhD on or before 01.01.2020.
- 5. The Panel shall remain valid for a period of one year from the date of DPC i.e. up to 26.11.2019.
- 6. The order of postings shall be issued separately.
