ORDER


Subject: Delegation of powers to Director General, (NIFT) to consider and decide cases relating to reimbursement of expenditure incurred by the employees of NIFT on the treatment of self or dependent members of their family for life-threatening diseases.

The proposal is to revise the delegation of powers to Director General, NIFT relating to reimbursement of expenditure incurred on account of OPD and IPD treatment of life-threatening diseases (as enlisted in Annexure -1) by regular employees and employees serving NIFT on long-term contract basis, on themselves or their dependent members of family beyond the limit of annual prescribed ceiling for Outdoor Patient Department (OPD) as notified in NIFT, Head Office OM No. NIFT/HO/E.I/Medical Policy/2016 dated 22.08.2016 and Indoor Patient Department (IPD).

The matter was placed before the 46th meeting of Board of Governors, NIFT held on 14.03.2019. BOG has approved the proposal that Director General, NIFT shall be competent to consider and decide the cases of the reimbursement of OPD expenses upto Rs. 2 Lakhs for diagnostic test/treatment for suspected/diagnosed life threatening diseases, and upto Rs. 5 Lakhs for IPD treatment for life threatening diseases, on actual basis to mitigate immediate hardship to the employee based. It was directed that expenditure beyond these limits, if any, shall be placed before the Board of Governors through the Finance and Audit Committee for Consideration.

The claim should be processed as per the guidelines of Central Services (Medical Attendance) Rules 1944).

These instructions will be applicable from the date of BOG i.e. 14.03.2019.

Some life threatening diseases are Major cardiac Surgery, Oncology cases, Organ transplant cases, Kidney failure, Brain tumor, Diabetes (acute) and Major Neurosurgical/Neurology Cases etc.
