1) Eligibility Criteria:

- a) Must have retired from Central Government/ State Government/PSUs/ Autonomous Bodies /Statutory Bodies as Group 'A' Officer (Level 10 & above of 7th CPC). However, preference will be given to the retired official from Higher Education Institutions (Universities).
- b) Must be well acquainted with the functioning of Government/Ministries/ Higher Education Institutions like IIT/IIM/NIFT/Universities etc.
- c) Should be well aware of various rules/regulations of Government of India, & capable to handle administrative matters. The candidate must also be acquainted with functioning of Higher Education Institutions and must possess knowledge about student affairs & examinations.
- d) The maximum age limit for candidates applying for Consultant shall not be more than 65 years on the closing date of receipt application.
- e) Must have very good working knowledge of computer (MS Office/ E- Office/ Internet/ E-mail.)

2) Terms & Conditions:
