Circular

In order to streamline the refund of security deposit to students on account of Hostel & Academics, following has been decided:

1) The Junior Assistant(s) / MTS(s) of the respective departments shall be the Nodal Officials for coordinating with the outgoing students regarding the refunds. - 2) Regarding the refunds on account of Hostel facility, Mr Vishal Kumar, Jr Assistant (+91-8899762035) shall coordinate with the students.
- 3) The concerned departmental assistants / hostel assistant shall coordinate with the students for issuance of NOC by the respective departments. It is not necessary for the students to come to the Campus for issuance of NOC, except for pendencies/ oustanding. In case of pendency/outstanding from any section/ department against the students, it shall be the responsibility of concerned students to fulfil those deficiencies/ pendencies; and only after meeting those deficiencies & pendencies, the NOC shall be issued by the concerned department/ section. After receiving the completed NOC issued by all concerned department/ section, the departmental/ hostel assistant shall initiate the file for refund in favour of the student. The file shall be sent to Accounts Section through the concerned CC for processing of the refund.
- 4) Students of batch (2017 -21) whose refund is still pending is listed as **Annexure-1**. All these students have not submitted their NOC. Hence the refund has not been initiated. All
