

**Instructions:**

1. The security charge of Hostel fees is the onetime payment only .
  - Fee may be deposited through Demand Draft in favor of 'NIFT Srinagar' payable at Srinagar or through online (NEFT/RTGS).

Upon payment of fee through online(NEFT/RTGS) mode, the online payment challan ( Given at the end) must be filled and mailed to:-

A seat in hostel will be secured upon depositing the DD or Online payment challan with the Accounts section subject to the verification and generation of the receipt thereafter. Unless challan is submitted with accounts section of NIFT Srinagar, the fee shall not be considered as paid, even if the online fee payment challan is made to the above mentioned Email- id. It is instructed to the students to carry the hard copy with them at the time of reporting.

2. After the verification of the online fee payment or submission of DD, Accounts Section will issue a receipt, copy of which needs to be handed over to the concerned hostel warden for the allotment of the room.
3. Allotment or rooms will be strictly on first cum first basis.
4. The student will not be allowed to stay in hostel if he/she fails to deposit hostel fee last date of hostel fee.
5. All decisions of NIFT authority in this matter is final
