#### 1. INTRODUCTION:

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 16 centres. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and short duration education program to address the specialized needs of professional and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Raibareli, Shillong and Srinagar.

NIFT, Srinagar, J&K was established in the year 2016 with undergraduate courses and presently running its campus at Rangreth, Srinagar (J&K).

#### 2. <u>OBJECTIVES & SCOPE OF WORK</u>

Consultants will be empanelled on hourly / part-time basis or as per the need and they are expected to provide services to the students and employees of the Institute as per the time schedule. In case of emergency, medical consultant may be contacted beyond the scheduled hours, even in late night hours (if required) and they are expected to render all possible support to the bonafide NIFT member.

Psychologist (Female) - 01	Counsellor is expected to be available in the Institute on 2 to 3 days in a week for minimum Two hours per visit. She is expected to counsel students having problems ranging from anxiety and depression arising from difficult study issues / results / home sickness / life issues to more serious mental health problems. Life issues could include bereavement, relationship difficulties or any such issues of adolescence, while mental health problems could include eating disorders, post-traumatic stress disorder (PSTD) or psychosis. The consultation should be kept confidential.		
Lady Doctor - 01	<ul> <li>To provide medical consultations to students and employees of the Institute.</li> <li>The medical consultant is expected to be available in the Institute on 2 to 3 days in a week for minimum Two hours per visit.</li> <li>In case of an emergency, she may be contacted by any of the Institute member at any time and she is expected to provide consultancy to the member.</li> </ul>

(iii) Institute reserves the right to terminate the process or reject any or all EOI proposals at any time or stage without assigning any reason thereof.

(iv) Institute shall in no circumstance whatsoever, be responsible or liable in any manner whatsoever, for any costs or expenses incurred or any loss suffered by the applicant, in connection with or in consequence of the preparation or delivery of any EOI, or compliance with any of the requirements of the Invitation for EOI or invitation for discussion or in any other manner.

(v) Any suppression or misrepresentation of a material fact(s) shall result in disqualification of the EOI proposal.

(vi) Canvassing in any form shall render the EOI proposal liable to be rejected.

(vii) The persons submitting EOI proposal shall be deemed to have read and duly considered all terms and conditions of this Invitation of EOI document and must acknowledge that it intends to receive an EOI proposal in accordance with the provisions of this document having accepted the terms and conditions as have been incorporated herein and/or that may be incorporated by the Institute through any Addendum (s).
