Post	Psychological Counsellor
Qualification	Master's Degree in Psychology/ Behavioural Psychology or relevant professional diploma from the Government recognised University. Doctoral degree holder is desirable.
Experience	At least Five Years of proven Professional experience including private practice.
Job Description	To counsel NIFT Students/ Staff having problems ranging from anxiety & depression arising from difficult study issues/ results/ home sickness/life issues to more serious mental health problems. Life issues could include bereavement, relationship difficulties or any such issues of adolescence, while mental health problems could include eating disorders, post-traumatic stress disorder (PTSD) or psychosis. The consultation should be kept confidential.
Timing	The Counsellor is expected to visit NIFT Campus twice a week (preferably Tuesday & Thursday) for minimum three hours per day (2:30 PM to 05:30 PM). In case of emergency, he/she may be contacted anytime as & when required.
Remuneration	He/ She will be paid consolidated remuneration of Rs. 700/- per hour & conveyance charges shall be as per GOI Rates
