1. For availing hostel facility, the student must pay hostel fee in one installment.

2. After depositing fee, the students must submit receipt/proof of payment by email at hostels.srinagar@nift.ac.in & sr.assistant.accounts.srinagar@nift.ac.in as attachment.
3. Due to limited availability of single-seater accommodation, students opting for the same shall initially pay the hostel fee applicable to the double/triple seater allotted. **Allotment of single-seater accommodation shall be subject to approval of the Hostel Allotment Committee and shall be valid for one semester (six months) only.** Upon approval, the applicable **differential fee must be paid within ten (10) days** of notification, failing which the allotment shall stand cancelled and be offered to the next waitlisted student. Any payment made for single-seater accommodation without prior committee approval shall be at the student's own risk, and the institution shall bear no responsibility for such payment. Students are advised to carefully read the fee circular before making any payment.

4. In case of any hostel room discrepancy room allotment will be done on First Come First Serve Basis as per the date and time of payment receipt.
5. Hostel fees will not be refunded once deposited on any ground. Mess fee is refundable for the un-availed period in case student is on leave subject to advance written notice of 7 days.
6. Mess fee is compulsory for all hostellers
7. Hostel fees must be paid on or before 15 February 2026. A late fee of ₹100 per day shall be levied for payments made from 16 February 2026 to 15 March 2026. Failure to pay the hostel fees, along with the applicable late fee, by 15 March 2026 shall result in expulsion from the hostel.
8. Above cited Hostel fees includes the following facilities: -
 - a. Bed with mattress
 - b. Almirah
 - c. Study table with chair
 - d. Washing machines (Pooled)
 - e. Mess facilities includes- Breakfast, Lunch, Snacks and Dinner.
 - f. Housekeeping. (6 days a week)
 - g. Security Guards.
 - h. R.O Drinkable Water
 - i. CCTV surveillance in common places.
 - j. Only electric heaters will be provided during specified winter season
 - k. Common Pantry (Micro wave oven , Electric kettle, Refrigerator)
 - l. Nurse is available in the hostel for medical treatment as per roster
 - m. Doctor is available for two days in a week. Online consultation is available for other days
 - n. Common TV in mess
 - o. First Aid
9. A NIFT vehicle shall be provided for medical emergencies at a charge of ₹300 per student
