1. Last date of depositing the fee for Jan-June, 2024 is **15th February, 2024**. Fee with a late fine of Rs. 100/- per day can be deposited till **28th February, 2024**.
2. The name of student will be struck from the institute rolls without any further notice in case of non-payment of fee after the specified date as mentioned above. They shall be allowed back on NIFT Rolls on payment of Tuition fee and additional re- registration charges of Rs 11800/- (10000+18% GST)
3. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are informed to contact the campus before the commencement of the session to complete the formalities. Repeat students will be required to pay Tuition fee and the re-registration fee of Rs 11800/- (10000+18% GST) per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim fee over and above-mentioned amount.
4. PG students of 3rd Semester will be required to pay the Alumni Association Membership Fee (One time) (Non-Refundable) of Rs 5600/-
